Scale: This project is the construction, operation, maintenance and transfer of

hydraulic engineering and ecological landscaping projects. Hydraulic engineering mainly includes, among others, regular dredging and cleaning of rivers, maintenance of river revetment on both sides, the construction of nine water storage buildings, the demolition and reconstruction of three bridges, the construction of one water pumping station and the regular inspection and maintenance of such buildings, bridges and water pumping station. Ecological landscaping projects mainly includes, among others, the cleaning, security and regular inspection of two waterfront parks (cultural and sports park and wetland park) and the maintenance and repairing of

greening landscapes, facilities and lighting of such parks.
