INTRODUCTION

SUCCESSFUL TENDER FOR PPP PROJECT

The board (the "**Board**") of directors (the "**Directors**") of the Company is pleased to announce that on 6 January 2020, Broad Greenstate Ecological Construction Group Company Limited* (博大綠澤生 態建設集團有限公司) ("**Broad Greenstate Ecological**", an indirect wholly-owned subsidiary of the Company) and Henan Sheng Ding Construction Group Co., Ltd. Location: Jiangyang City, Guangdong Province

Scale: Construction of the project mainly includes site levelling, land excavation and filling works, construction of greenways along the route, greenerybased remodelling of the former levee crown roads of Moyang River, pavement of garden roads and esplanade platforms, ecological car parks, water-side boardwalks and platforms, and construction of such architectures as posts, bird hides and racks within the site to meet tourists' demand for recreational services. The project also involves the landscaping of wetland ground for future landscape purpose, development of greenery-based park landscape and construction of recreational facilities for sports activities within the project land along the ecological river bank, coupled with ramping up outdoor water supply and drainage, electric lighting, signage system and ancillary facilities within the project land.
